Dear Colleagues:

You may be aware of NIH's new [Policy for Data Management and Sharing](#), which **goes into effect on January 25, 2023**. NIH's policy requires researchers to prospectively plan for how scientific data will be preserved and shared through submission of a Data Management and Sharing Plan with most NIH applications and to implement the approved plan if a project is funded.

A cross-campus [workgroup](#) has been formed to assist faculty and research administrators in navigating the requirements of this policy. A Data Management Response Team with experts from various areas has also been assembled to support this initiative.

The Data Management Response Team will be hosting virtual office hours via Zoom on **Wednesday, January 11, 2023, from 10:00 a.m. to noon**. Researchers are welcome to sign in any time during that window to ask questions or get help with their data management and sharing plans. Please [register](#) in advance if you plan on attending.
